

Shaxsiy ma'lumotlarni olinishi va qayta ishlash shartlari	Terms for Collection and Processing of Personal Data
Ushbu bilan elektron arizada ko'rsatilgan barcha ma'lumotlar shaxsan o'zim tomonidan to'ldirilganligini hamda undagi ma'lumotlar to'g'ri va aniq ekanligini tasdiqlayman.
